

## **Company recommendations:**

**Targets:** The company has set a long-term decarbonisation target. To align with its 1.5°C pathway, the company should aim to be carbon neutral by 2035 as this is the expectation for electricity generation companies with assets in advanced economies.

**Emissions reductions and reporting:** The company's emissions contrast with its 1.5°C pathway which requires it to make substantial decreases in its emissions intensity.

<u>Transition plan:</u> The company can improve the elements of its transition plan by ensuring it includes financial commitments. It is recommended that individuals with oversight of climate change issues have relevant expertise.
